Homeless Youth Services

428 clients served



Homeless Youth Services provides emergency shelter, housing, and support to homeless youth, ages 12 to 24, including young people who are pregnant or have children. The goal of the program is to lift youth out of a situation of desperation and despair, and give them the resources, support, and guidance they need to care for themselves for the rest of their lives.

The Tucson Police Department reports that more than 3,000 teenagers run away in the city each year. Since 1988, Our Family has operated Reunion House,

the only crisis shelter for homeless and runaway youth in Pima County. The facility has twenty beds for kids ages 12 to 17, including young people in the care of the Department of Child Safety. Reunion House provides safe, supervised emergency shelter until a permanent home is found.

IMPACT STAT: Our Family's Street Outreach Program made 1,440 outreach contacts with youth living on the street and distributed hygiene kits, food, water and information on how to get help.

IMPACT STAT: 30% of the runaway and homeless youth Our Family serves through street outreach have escaped homelessness and progressed toward stable housing.

SUCCESS STORY: When Jacob & Christina* came to us they were on the verge of being on the street. They had a 3 year-old son and an infant daughter, and neither of them had a high school diploma or a job. Within 9 months of entering our couples housing program, Jacob earned his diploma, became employed, and enrolled in a heating & cooling (HVAC) certificate program through one of our community partners. Christina enrolled in a high school program and obtained a part-time job. Jacob & Christina's son and daughter are thriving. The couple credit Our Family with giving them the foundation they so desperately needed to become successful.

IMPACT STAT: Within three days of entering Reunion House, 85% of kids are enrolled in and attending school. 247 teens called Reunion House home this year.





Homeless Family Services

978 clients served

Home is at the center of all of our lives. It is where we raise our families, make our most cherished memories, and spend our retirement years. The quality and consistency of housing is directly linked to personal health, success in school, and family stability—yet over 500 young people sleep in cars, on couches and on the streets in Pima County every night. Our county has the highest rate of homelessness in the State (Annual Report on Homelessness in Arizona 2015).

Our Family Services offers a continuum of housing options depending on the unique circumstance of each family we serve. These include homeless prevention



services, emergency shelter, rapid rehousing, and affordable housing options. We also provide intensive case management, counseling, job search help and education assistance to prepare families to become independent. Our goal is for families experiencing homelessness to gain financial and emotional stability, so they no longer need the services and support we provide.

IMPACT STAT: 89% of families in Rapid Rehousing exited to permanent housing.


SUCCESS STORY: Nicole and her infant daughter came to Our Family Services in dire need of housing. Nicole reported that she had been staying in her car while her child was able to stay with relatives so as to not be homeless with her mother. Nicole experienced a great amount of stress being separated from her daughter. While homeless, she kept her full time job. Within days of entering our Rapid Rehousing program Nicole moved into a new home and was reunited with her daughter. By program exit Nicole had maintained her employment and housing, and had re-enrolled in school.



IMPACT STAT: 90% of Emergency Shelter clients developed a goal plan for self-sufficiency and accessed community services in support of those goals.

Elder Legacy Services

723 clients served



Providing compassionate care and empowering support for elders is integral to Our Family's vision of a stronger community. We are helping to redefine what it means to age with dignity and grace. In fact, one in every five individuals we serve is a senior or elder in need of support. Our Family's Elder Legacy Services includes the Senior Companion Program, in-home elder counseling, elder mediation, and Elder Circles. This complementary menu of services assists elders and their families in approaching end-of-life with peace of mind and the greatest independence possible.

SUCCESS STORY: One of our Elder Legacy clients was a child during WWII. She lost all of her uncles to war, her brother to sickness, her father to her parents' divorce, and she survived the horrors of that bitter and cruel era—leaving her with historical trauma. When she first came for therapy, she could hardly stop crying. Later, she began to share her story, and her tears became drops of wisdom. Now, she is finding the gifts of her personal experiences, is better equipped to strengthen her family relationships, and is preparing a positive legacy.



Success Statement: "I have been encouraged to keep living; aging doesn't have to be scary."

Counseling 230 clients served

Our Counseling program offers family support and crisis stabilization to youth, families, seniors, and adults with disabilities. We focus counseling services on meeting needs that are not met by other systems – serving those who might otherwise fall through the cracks.

SUCCESS STORY: We recently received a panicked call from a father who was concerned about his 19 year old daughter, devastated by a break up. The daughter's despair ran so deep that the father was concerned she would take her own life. Not



wanting his daughter to be further traumatized by a hospital stay, he was desperate for us to meet with her that very day. Fortunately, our Counseling Supervisor was able to visit and ensure the young woman's safety, while empowering her father to care for his daughter moving forward.

Center for Community Dialogue

1,688 Tucsonans served

The Center for Community Dialogue helps Tucsonans discuss challenging issues in a skilled, civil, and respectful way. We offer mediation and facilitation, communication trainings, and events that build skills and spread constructive dialogue.

Center Community Dialogue

SUCCESS STATEMENT:

"I have practiced law for over 35 years and have taken dozens of continuing legal education courses... Our Family's [Basic Mediation] training ranks among the top two or three programs in which I have participated, and certainly the best one focusing on mediation. I highly recommend it."



Within a month of participating in mediation, 100% of those who responded said that the agreement was still in place.



Information and Referral *65,158 clients served



*65,158 people in Southern Arizona accessed resources through Information and Referral Resources, Arizona 2-1-1 and 211arizona.org.

Our Family's Information and Referral Resources program works in partnership with Community Information and Referral Services 211 Arizona, which operates the 2-1-1 telephone helpline. Together, the two agencies maintain a free, online database of thousands of health and human services providers across Arizona.

Healthy Futures

778 clients serv

Our Family's Healthy Futures program focuses on strengthening communities by assisting youth and families in making healthy decisions. We offer workshops and trainings for at-risk kids and young adults on topics including parenting, life skills, art expression, and anger management.

Success Story: Our partnership with 4R Community Alliance and Changemaker High School resulted in a Pima County bond award that will create a pedestrian bridge over a flood zone near Roberts-Naylor Elementary School.

Children will no longer face the dangers of heavy floodwaters while trying to get to class.

IMPACT STAT: We linked an additional 2,570 people to vital community resources at outreach events, neighborhood meetings, and community celebrations.





People Served By Age:


